The European Union,

Acknowledging the root causes of political extremism,

Affirming the diversity of different right-wing extremist movements throughout Europe,

Upholding the values of the European Union and international law,

Recognizing the vulnerability of refugees in extremist societies,

- 1. Recommends for a new educational program to be created under the European School Education Program which would facilitate,
 - a. Redevelopment of school education curriculum in regions that are statistically proven through census data to have high amounts of extremism in the interest of deradicalizing the youth
 - b. Trains teachers to identify the sign of radicalism in Youth, so effective measures could be taken for de-radicalisation;
- 2. Proposes to create an organization Project Diversity with the aim of,
 - a. Educating the European youth on the effects of extremism,
 - b. Cultivating community engagements to foster diversity,
 - c. Promoting cultural tolerance throughout European nations,
 - d. Assuring interfaith and interethnic dialogue to foster unity;
- 3. Recommends the Anti Corruption (MIMW) framework by Slovakia,
 - a. Mechanisms through which corrupt officials in government can be identified,
 - b. Information of all servants, cash/noncash assets in the country or abroad that they or their immediate family owns to be given to anti-corruption agencies,
 - c. Wages to be increased of lower level officers to make sure there is no need for bribes in the first place;
- 4. *Urges* for the enhancement of the European Counter Terrorism Centre (ECTC) with a 10% budget increase to expand its operations and further address the pressing issue of extremism in such a way:
 - a. Adopting an ECTC Accreditation System:
 - i. Wherein NGOs that work to combat any form of extremism shall be eligible to apply for accreditation,

- ii. Wherein NGOs that are accredited are provided with additional financial support for their framework,
- iii. Wherein NGOs that are accredited are to submit intelligence reports to the ECTC including recommendations and other relevant information,
- iv. Wherein intelligence reports of NGOs will have a standardized format to be provided by the new system;
- 5. *Encourages* a universal legal framework rework recognizing the need for stricter punishments against all forms of discrimination, applicable to all EU member-states through,
 - a. Increasing repercussions via,
 - i. Imposing longer penitentiary sentences not less than 1 year, and
 - ii. A fine not exceeding 50,000 Euro;
 - b. Offering a deradicalization program to individuals who violate this clause, and to those who seek deradicalization.
 - c. Offering assistance to victims of extremism seeking asylum;
- 6. Affirms the Combating Poverty (NLMR) Framework by Slovakia,
 - a. NGOs to facilitate job opportunities,
 - b. Labor market reforms to reduce barriers to unemployment,
 - c. Minimum wage to be regularly viewed and adjusted, and
 - d. Reskilling of workers in declining industries;
- 7. Recognizes how social media could affect Political extremism,
 - a. Uses AI to detect if content would be considered to fall under political extremism.
 - b. Also uses human consideration (hybrid model) to determine if the content is extremist propaganda as AI could potentially mis-determine if the content is extremist or not.
